## **I. CALL TO ORDER, ROLL CALL**

Maria Brown, Gulf of the Farallones National Marine Sanctuary (GFNMS) Superintendent, clarified the use of motorized personal watercraft (MPWC) within the Monterey Bay National Marine Sanctuary (MBNMS) and specifically at the Mavericks surf spot. The area from Rocky Point to Pigeon Point is in the MBNMS and the GFNMS assists with management in that area. The Mavericks surf area is in the MBNMS and MBNMS regulations apply, but GFNMS manages it. At no time have sanctuary regulations prevented the use of MPWC for assistance with rescue. There was extensive public comment during the joint management plan review on MPWCs. Some of the public comment received stated surfers would like to have a volunteer surf rescue squad. MBNMS regulations allow for volunteer surf rescue squads as long as they are under a public safety agency.

## **II. PUBLIC COMMENT**

The following members of the public provided public comment for items not on the agenda: John Donaldson, Shawn Alladio, Scott Frazier, Linda Ciotti, Sabrina Brennan, Frank Quirarte, Robert and Debbie Trette, and Paula Spidel. Comments focused on safety concerns with regard to the MPWC rule.

## **III. WEST COAST REGION UPDATE**

Carol Bernthal, Acting West Coast Regional Director, introduced herself and explained that Bill Douros is on a ten-month detail as the Acting Deputy Director for the Office of National Marine Sanctuaries. Carol explained she is the superintendent of the Olympic Coast National Marine Sanctuary. Carol highlighted the Ocean Acidification Task Force, the deep sea coral research initiative, and better utilizing dwindling budgets as priorities for the west coast region this year. She also mentioned that the west coast regional office is looking into larger NOAA initiatives such as Coastal and Marine Spatial Planning.

## **IV. ENFORCEMENT UPDATE**

NOAA Office for Law Enforcement (OLE) Supervisory Criminal Investigator Dan Torquemada, Special Agent in Charge for Area 3 in California, announced Dayna Matthews would no longer

be the NOAA OLE contact for sanctuary advisory councils. A replacement for Dayna Matthews has not been assigned. Torquemada stated NOAA OLE will be present for the Mavericks surf contest.

Advisory council members had questions regarding use of MPWC for public safety at Mavericks. Other advisory council members expressed concern about the Sanctuary's MPWC regulation being able to adequately address surfer safety needs, and a working group was suggested. The GFNMS advisory council chair allowed for further public comment, which continued concern about safety issues. Scott Kathey, MBNMS Regulatory Coordinator, clarified that MBNMS regulations allow an emergency exception for Good Samaritan or public safety agency use of MPWCs to rescue someone in distress. Pillar Point Harbor Patrol or another qualified public safety agency could deploy MPWC during high surf to conduct standby patrols in areas where they know emergency calls are likely, even if there is no emergency at the time of launch. These are public safety agencies who train for surf rescue. Their mission is to save lives and perform ocean rescue in a very dangerous environment. NOAA depends on public safety agencies to determine who is qualified to perform water rescue. NOAA is not a public safety agency and does not determine who is qualified to perform water rescue.

NOAA does not tell safety agencies how to train, where to train, or ocean conditions for training. NOAA is working with public safety agencies to find out what their training needs are and collaborate on solutions to any environmental conflicts. All agencies were given guidance by MBNMS to continue training and operations as they have in the past until formal training permits are issued. This permit process is like no other in MBNMS to date. Sanctuary staff work with the agencies throughout the permit process and negotiate solutions to any conflicts between desired training practices and resource protection. GFNMS advisory council Chair Richard Charter supported the creation of a working group to look at large surf MPWC safety issues. GFNMS will take the lead on this issue.

## **V. PORT ACCESS ROUTE STUDY (PARS)**

Michael Carver, Cordell Bank National Marine Sanctuary Operations Coordinator, provided a presentation on the United States Coast Guard Port Access Route Study (PARS). Michael has been working with the Coast Guard through this process. ### **XIII. MEMBER ANNOUNCEMENTS**

Sanctuary Advisory Council members from both MBNMS and GFNMS made the following announcements.

Simona Bartl, MBNMS Education, suggested that for future joint sanctuary advisory council meetings, the seating arrangement should be more integrated. Also, the Sanctuary Education Panel (SEP) met for the first time in eight months. The SEP is interested in improving their online presence in order to be more useful to educators in the area, and to think about who should be on the SEP. Finally, Moss Landing Marine Lab is having an open house April 30- May 1.

Randy Herz, MBNMS Diving, announced that National Geographic has an excellent article on artificial reefs this month.

Richard Keuhn, GFNMS At-Large Marin/Sonoma, announced that Diane Harkey, a member of the California State Assembly from Dana Point, has introduced AB 206. This bill would exempt municipal fireworks shows from the California Environment Quality Act and the California Coastal Act regulation by the California Coastal Commission. This could have a detrimental impact upon nesting seabirds, whose nesting season - April through August - happens to coincide with the 4th of July. Paul Michel announced that the Sanctuary Exploration Center broke ground in November and construction is going well. MBNMS anticipates taking ownership of the building late December 2011 or early January 2012.

Chris Harrold announced the MBNMS Sanctuary Currents Symposium on April 9<sup>th</sup> at California State University at Monterey Bay, entitled, Ripple Effects.

Maria Brown announced that on February 25<sup>th</sup>, the GFNMS will hold a Volunteer Appreciation Event. Also, the San Francisco Ocean Film Festival will begin March 9<sup>th</sup>.

Bob Breen, GFNMS Education, announced that a marine protected areas watch program is being created in San Mateo County.

Geoff Shester, MBNMS Conservation, announced that National Marine Fisheries Service will soon be requesting relevant data for a 5 year review of groundfish Essential Fish Habitat in all of the west coast exclusive economic zone. Also, he urged everyone to support the shark-finning bill introduced in the state legislature.

LT Steve Arnwine announced that he will be transferring to Key West to take control of a patrol boat, and will be leaving the advisory council. He does not know who will be replacing him, but he has enjoyed working with both the MBNMS and GFNMS Advisory Councils.
